Restate the FCRA law pertaining to the 30 day rule and put them on notice that they will be in violation of the law if they fail to remove the data.

SAMPLE: Cease and Desist letter – to stop debt collection

According to the Fair Debt Collection Practices Act, [15 USC 1692c] Section 805 (c): Ceasing Communication,

you must stop all communication with me after receiving a letter that I no longer wish to communicate with you.

How to write a Demand For Payment Letter to Collect on

The basic premise of your letter is this: State why you have a dispute, and that if this particular attempt at negotiation fails, you will take the case to court.

You can also request a free copy if: you've been refused credit within the past 90 days, or; your credit-related personal information has been corrected; At other times a credit reporting body may charge a fee, but it mustn't be excessive.
